DEAR MEMBERS AND FRIENDS

It gives us great pleasure to publish the second annual report of the Sino-German Center (SGC) at the Frankfurt School of Finance & Management. We are delighted to share with you the wide range of activities and the ongoing progress of the center in the year 2024.


The activities include our well-known virtual roundtables with leading experts on relevant and current topics like the results of the 'Two Sessions Meeting' and the '3rd Plenum' as well as the outlook for the China-US relations after the presidential election and the rationality of extra tariffs by the EU on Chinese EV imports. We also continued the Sino-German Expert Dialogues on Sustainable Finance Products and Practices in cooperation with GIZ, China. We were particularly pleased that the Chinese Consul General in Frankfurt, Yiyang Huang, joined the Sino-German Workshop on *The Financial Centre of Frankfurt and Shanghai* together with the President of Frankfurt School, Prof. Nils Stieglitz, and high representatives of both cities.

At the end of the year, two research projects were concluded. The book *The Rise of China's Economy: Past, Present, and Future*, kindly sponsored by the Hans and Ria Messer Foundation, was published by Springer. The project *Corporate Venture Capital in China*, funded by the German Federal Ministry of Education and Research (BMBF) and jointly conducted with the Venture Lab of TH Aschaffenburg, was concluded with a comprehensive workshop and summing up academic as well as practitioner papers. A new working paper *The Great Power Rivalry in the 21st Century: China vs the United States* has been released in the SGC's Working Paper Series. With several articles and interviews in professional journals and conference contributions, the SGC was again able to position itself as a relevant contributor to Sino-German affairs in the field of business and the economy.


In the past year, we also continued the joint meetings of the Board of Trustees and the Steering Committee of the SGC. The purpose of these high-level meetings is to exchange views on political and economic relations between Germany and China and to advise the SGC on its further development. In the spring, Dr Philipp Rösler, former German Vice-Chancellor and CEO of Consensor AG, as well as a board member of Global Neighbours, held a keynote speech on *China und die neue Geoökonomie*. At the autumn meeting, Christoph Kirsch, Executive Advisor of Bosch Management Support GmbH, presented the topic: *Die neuen Herausforderungen der deutschen Automobilindustrie in China*. Both presentations were very well received, followed by intensive discussions.

Finally, we would like to thank you for your continued support over the past year. Without it, we would not have been able to drive the SGC success story forward. We hope that you will continue your commitment to the Sino-German Center in the Year of the Snake!

The Financial Centres of Frankfurt and Shanghai

Frankfurt China Roundtable with Yiyang Huang, the General Consul of China in Frankfurt

The Frankfurt China Roundtable is a regular event jointly organised with the China Construction Bank (CCB), Frankfurt Branch. The topic of the event in May was "The Financial Centres of Frankfurt and Shanghai". The Consul General of China in Frankfurt, Yiyang Huang, gave a keynote speech in which he emphasised the importance of Sino-German cooperation in the financial sector and beyond. Other keynote speakers were Michael Kotzbauer, Member of the Board of Commerzbank AG, and Chao Yang, Executive Vice Major of Pudong New Area, who spoke virtually from Shanghai. Both speakers stressed the importance of further strengthening the links between the two financial centres. In the second session, Hubertus V ath, Managing Director of Frankfurt Main Finance, gave a speech on the journey and future of Shanghai and Frankfurt. The Chinese speakers Dr. Jian Xiao, Director General of Lujiazui Financial City Authority, and Meijun Guo, Deputy General Manager of the International Office of CCB in Beijing, expressed their hope and willingness that the Sino-German business in general and the financial exchange in particular will further increase in the future. The event was opened by Prof. Nils Stieglitz, President of the Frankfurt School, and moderated by Prof. Horst L ochel and Prof. von Rosen, both Co-Chairs of the SGC, and Xinlei Sun, Deputy General Manager of CCB, Frankfurt Branch, who concluded the event with a closing speech summarising the main results.

Sino-German Workshop on Sustainable Finance

Jointly with GIZ-China, CIFA, IFS, and Climate & Company

The Sino-German Center co-hosted the 3rd workshop of the Sino-German Expert Dialogues on Sustainable Finance Products and Practices in October at Frankfurt School jointly with GIZ, the Climate Investment and Finance Association of China Society for Environment and Science (CIFA), the Institute of Finance and Sustainability (IFS), and Climate & Company.

This time the workshop focused on sustainable equity products and sustainability disclosure. Prof. Horst Löchel, Co-Chairman of the Sino-German Center and Professor of Economics at Frankfurt School, and Thorsten Giehler, Director at GIZ and former country head of China stressed the importance and huge potential of the topic for the Sino-German cooperation in their welcoming notes. Mr. ZHU Qingfeng, Secretary General and Vice Chairman of the Climate Investment and Finance Association, and Dr. Aaron Kamm, Referee for the Financial Centre of Frankfurt at the Ministry of Economics at the State of Hessen, hold the keynote speeches.

This was followed by two consecutive workshops on 'Sustainable Equity Products', chaired by CHENG Lin, Director of the Center for International Collaboration (IFS), and on 'Sustainability Disclosures', moderated by Dr. Sven Reimer. The discussions showed how equity products and disclosures could support sustainable finance as an instrument for environmental protection in both Germany and China. The concluding remarks of the workshop were given by Prof. Rüdiger von Rosen, Co-Chairman of the Sino-German Center.
