

DEAR MEMBERS AND FRIENDS

It is our great pleasure to present the Annual Report of the Sino-German Centre (SGC) at Frankfurt School of Finance & Management for the year 2025. We are delighted to share with you the wide range of activities and the continued progress of the Centre throughout the year.

Our activities included the well-established virtual roundtables with leading experts on timely and relevant topics such as the outlook for China's economy, the rise of the large language model DeepSeek, Germany's China policy, the ongoing internationalisation of the Renminbi, and Chinese citizens' perceptions of Germany. We also continued the Sino-German Expert Dialogues on Sustainable Finance Products and Practices in cooperation with GIZ China, with workshops held in Frankfurt and Beijing. In addition, we organised a scientific colloquium on China's economy and participated in the conference on economic security jointly organised by the Frankfurt Competence Centre of German and Global Regulation (FCCR) at Frankfurt School and the Europe Institute of Saarland University. Through numerous articles and interviews in professional journals, newspapers, and conference contributions, the SGC once again positioned itself as a relevant and visible contributor to the Sino-German business and economic dialogue.

Over the past year, we also continued the joint meetings of the Board of Trustees and the Steering Committee of the SGC. These high-level meetings serve as a platform for exchanging views on political and economic relations between Germany and China and for advising the SGC on its further development. At the spring meeting, Stefan Messer, Chairman of the Supervisory Board of Messer Group, delivered a keynote address entitled "Experiences and Future Prospects of Messer Group in China." At the autumn meeting, Huang Yiyang, Consul General of the People's Republic of China, spoke on "Sino-German Relations in a Changing Geopolitical Environment." Both presentations were very well received and followed by intensive discussions.


In 2025, there were also personnel changes in the governance of the Centre. The General Meeting of the SGC approved the proposal of the Executive Board to appoint Thorsten Giehler, Head of the Economy, Employment & Social Development Department at the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ), as Co-Chair of the SGC, succeeding Prof. Rüdiger von Rosen. Workshop on Climate Risk Management and Sustainability Disclosures

Jointly with GIZ, CIFA, FS-IAS, and IFS Frankfurt, June 11th

The Sino-German Centre co-hosted the 3rd Workshop of the Sino-German Expert Dialogues on Sustainable Finance Products and Practices on June 11 at Frankfurt School, together with the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ), the Climate Investment and Finance Association of China (CIFA), the International Advisory Service at Frankfurt School (FS-IAS), and the Institute of Finance and Sustainability (IFS).

This workshop focused on climate risk management and sustainability disclosures. The event was opened by Prof. Horst Löchel, Co-Chair of the Sino-German Centre, followed by welcome remarks from Dr. Julia Wendel-Hübner, Fellow and Sustainable Finance Advisor at the Hessian Ministry for Economic Affairs, Energy, Transport, Housing and Rural Areas; Mr. Marcus Lange, Director of the Asia Division at GIZ; and Mr ZHU Qingfeng, Vice Chairman and Secretary General of CIFA. Keynote presentations were delivered by Ms. Carola Menzel, Head of the UNP Centre at Frankfurt School, and Prof. Liang Xi, Professor of Infrastructure Sustainable Transition at University College London and Executive Member of CIFA.

The two subsequent panel discussions included representatives from CIFA, Deutsche Bundesbank, Deutsche Bank AG, FS-IAS, Hengfeng Bank, IFS, and Ping An Insurance Group. The workshop concluded with closing remarks by Prof. Rüdiger von Rosen.



Sustainable Finance Workshops on Financing for the Zero Carbon Park Transition

Jointly with GIZ, CIFA, FS-IAS, IFS, and Taicang High-tech Industrial Development Zone
Beijing, October 18th



Following the Sino-German Workshop on Climate Risk Management and Sustainability Disclosures held in Frankfurt in June, a follow-up workshop on Financing the Zero-Carbon Park Transition was jointly organized by the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ), the Institute of Finance and Sustainability (IFS), Frankfurt School of Finance & Management, the Sino-German Centre of Finance and Economics (SGC), and Taicang High-tech Industrial Development Zone, Jiangsu. The workshop took place on 16 October 2025 in Beijing.

The workshop was opened by Ms. Qi Lan, Team Leader Climate, GIZ East Asia. Welcome remarks were then delivered by Ms. Bianca Fluck, Economic Section, Embassy of the Federal Republic of Germany in Beijing; Dr. Ma Jun, President of the Institute of Finance and Sustainability (IFS); and Prof. Horst Löchel, Co-Chair of the Sino-German Centre of Finance and Economics (SGC) at Frankfurt School.

Their statements underscored the importance of deepening Sino-German cooperation in sustainable finance and industrial decarbonization, highlighting the role of industrial parks as key platforms for green transformation and the need for innovative financing instruments, improved governance, and capacity building to support low-carbon development.

Following the opening session, the workshop featured keynote presentations by Ms. Yang Ping, Director of the Financial Market Division of the Research Bureau of the People's Bank of China, on "The Status Quo and Recent Developments in Transition Finance Policy in China," and by Mr. Eugen Doce, Head of International Advisory Services at Frankfurt School, on "De-risking Innovative Investments to Support the Low-Carbon Transformation of Industrial Sectors."

The keynotes were followed by two panel discussions featuring representatives from ABB, the China Beijing Environment Exchange, the China Carbon Neutrality Committee of the China Energy Conservation Association, CICC, the China National Institute of Standardization, Deutsche Bank Group Asia Pacific, GIZ China, Huaxia Bank, IFS, and Taicang High-tech Industrial Development Zone. The workshop concluded with closing remarks by Dr. Janto Hess, Project Director, Sino-German Cooperation on Climate Change – Climate Partnership, GIZ East Asia.

China Colloquium

The Strategy of 'New Productive Forces' and the Future of China's Economy



On 21 May 2025, the Sino-German Centre at Frankfurt School hosted a high-level symposium on the future of China's economy to mark the release of the book *The Rise of China's Economy: Past, Present, and Future*, written by Prof. Horst Löchel and Tim Jablonski and published by Springer. The focus of the symposium was China's future growth model. Around 30 participants from academia and business took part in the discussion, which was moderated by Prof. Rolf D. Cremer.

The main speakers were Professor Yeling Tan from the Blavatnik School of Government of Oxford University, Prof. Klaus Mühlhahn from the Institute for China Studies at FU Berlin and Prof. Löchel. The opening remarks were delivered by the President of Frankfurt School, Prof. Nils Stieglitz, as well as representatives of the Hans and Ria Messer Foundation, which generously supported the writing of the book. The concluding remarks were given by Prof. Bertram Schefold of Goethe University Frankfurt.

A German edition of the book will be published shortly. The edition has been extensively updated and rigorously revised to reflect the latest academic research and developments.
